# Enrollment and Outreach Committee MEETING MINUTES December 12, 2023, 8:30 a.m. Moore Hall, Room 215

#### **Call to Order**

Dr. Tom Zavelson, Chair, called to order the FSDB Enrollment/Outreach Committee Meeting at 8:30 a.m. in Moore Hall's room 215.

# **Approval of Meeting Minutes**

Mr. Kramer moved to approve the April 14, 2023, Committee Meeting Minutes. The motion was seconded by Mrs. LeFors and was carried unanimously by the Committee.

# **Unfinished Business**

No unfinished business.

#### **New Business**

Ms. Ardis introduced Kim Carr and Jennifer Cato to the Committee and allowed them to present to the Committee.

Ms. Cato explained that the Early Intervention programs she and Ms. Carr run are primarily not on the FSDB Campus.

The following are points from the presentation:

- Progression of Services to families with children who are deaf/ hard of hearing, blind/visually impaired, and dual sensory impaired.
- The regional and statewide services provided.
- The State of Florida has a mandated newborn hearing screening. Of those screenings there are approximately 350 identified annually.

- The Joint Committee on Infant Hearing aims to screen every newborn by one month of age, diagnose or "identify" by three months, and enroll in an early intervention program by six months.
- FSDB has a contractual agreement with the Department of Health and the Early Hearing Detection and Intervention Office.
- The program is named the Parent Empowerment Program (PEP).
- FSDB has received through the PEP almost 350 referrals since July 1.
- The referred children are enrolled in the Early Steps Program.
- Early Steps also helps families enroll their child into the school system when they turn three years of age so there are no gaps in services.
- Early Steps helps parents through the process via a single point of entry.
- Currently, we serve 444 families in 57 of the 67 counties statewide.

Ms. Carr explained that there is no newborn screening for Blind/VI babies. If the doctor or the family identifies a visual impairment, the newborn will be screened, but children are often not identified until parents notice a problem.

- American Ophthalmologic Association recommends that babies receive an exam by six months if there are concerns.
- FSDB has established relationships with ophthalmologists, hospitals, and doctors' offices.
- Children with secondary disabilities are referred to Early Steps. When they do evaluations, babies with visual impairments are referred to FSDB.
- Division of Blind Services provides funding.
- Currently serve 265 families in the Panhandle, Jacksonville, Gainesville, and West Palm areas of Florida.

The following information was shared in detail with the Committee by both Ms. Cato and Ms. Carr.

The Committee asked several questions that Ms. Ardis, Ms. Cato, and Ms. Carr answered.

Enrollment and Withdrawal updates – Ms. Ardis updated the December Enrollment Data. Currently, 520 students are enrolled at FSDB. This number does not include the Early Intervention children.

Dr. Zavelson asked what percentage of children in the Early Intervention Program come to FSDB.

Ms. Cato explained why that is difficult to determine because many parents won't send their small children to a boarding school, and when older children are enrolled at FSDB, the parents don't always report what type of services they received in their child's early years.

Mr. Kramer asked if there is relocation help that FSDB can offer parents who do not want to put their young children in a boarding program.

Ms. Ardis explained that we do not have funding to help them relocate, but we provide support for parents to attend an admissions process.

The next Enrollment Committee meeting will be on April 12, 2024. Dr. Zavelson thanked everyone and adjourned the meeting.
